Item #13 - For Possible Action: Revision to DVCD Contract #2021-3 Exhibit A

Mr. James explained the need to revise the language in DVCD Contract #2021-3 to include grant fund use to cover general operating/administrative costs as has been routinely allowed but not been specifically addressed in contract language, and to include this language in future contracts for conservation districts.

Director Koerner made a motion to approve the Revision to Contract #2021-3, Exhibit A and add this language to future Conservation District contracts as presented. The motion was seconded by Director Scharmann and unanimously approved by the Board.

<u>Item #14 - For Possible Action: Approval of Compensatory Time Off In-Lieu of Overtime</u> & Emergency Closing or Early Release Policies

Mr. James reported on the questions that arose among staff due to the recent Carson City Snow Day. It was determined that the CWSD should have this addressed in the Personnel Policy Manual to avoid confusion in the future. Also, earning comp time off in lieu of overtime pay has been our practice, but not addressed in the manual. Staff is requesting that this be added as well.

After a brief discussion, consensus was to add to proposed Section 4.11:

"Employees must sign an Election of Compensatory Time in Lieu of Overtime Pay form which will be kept in their personnel file. By electing compensatory time off in lieu of cash payment, compensatory time off must be used within 30 days of the date earned."

> Director Hales made a motion to approve the Compensatory Time Off In-Lieu of Overtime & Emergency Closing or Early Release Policies with added language to Section 4.11 as shown above. The motion was seconded by Director Gardner and approved by the Board 11-1-0.

<u>Item #15 - For Possible Action: Approval of Funding Assistance for Emergency Flood</u> <u>Damage Policy</u>

Mr. James explained the need to make emergency funds available to help fund urgent repairs to the Carson River. During this record-breaking year of precipitation and snowpack, the ensuing damage to riverbanks is an emergency event that requires immediate action to mitigate further damages. The purpose of the Flood Management Fund was for this scenario.

After discussion it was agreed that the proposed policy be amended to add "that must be" approved by the CWSD Finance Committee.

Director Hales made a motion to approve the Funding Assistance for Emergency Flood Damage Policy as amended. The motion was seconded by Director Giomi and unanimously approved by the Board.

<u>Item #16 - For Possible Action: Approval of Carson Valley Conservation District Emergency Funding Requests for 4 projects totaling \$208,805</u>

Mr. James reported Carson Valley Conservation District (CVCD) has documented streambanks along the Carson River that are experiencing damage due to high runoff. Carson City and CVCD are requesting emergency funds to make repairs before the high spring runoff causes more severe damage. These areas needing emergency repair to erosion of riverbeds threaten loss of land, trees and trails which will lead to further flooding and damage if not addressed immediately. CWSD has received a total of \$208,805 in emergency funding requests for the following areas:

- 1) Buzzy's Ranch \$80,060
- 2) Charney River Restoration Site #4 \$50,000
- 3) Highway 88 Bridge \$64,560
- 4) Riverview Bridge \$14,185

Lindsey Boyer reported on the damage at Buzzy's ranch and the urgent need to save the banks and a trail near the site. This is the biggest problem identified in Carson City due to the record rain/snow levels. Carson City is working with CVCD to get these repairs done immediately. Mr. James discussed the potential of all these riverbank damages to exacerbate if not repaired asap.

Director Scharmann made a motion to approve all the funding requests as submitted, adding a 10% contingency if increased costs warrant. The motion was seconded by Director Gardner and unanimously approved by the Board.

<u>Item #17 - For Discussion Only: Overview of the Water Picture for the Carson River Watershed</u>

A record 1.1 million AF is predicted to come down the river, which is more than 3 times the amount the Lahontan can hold! We are currently at 291% of average precipitation and 320% of average snowpack. We continue to break records, including low temperatures and low-level snow.
